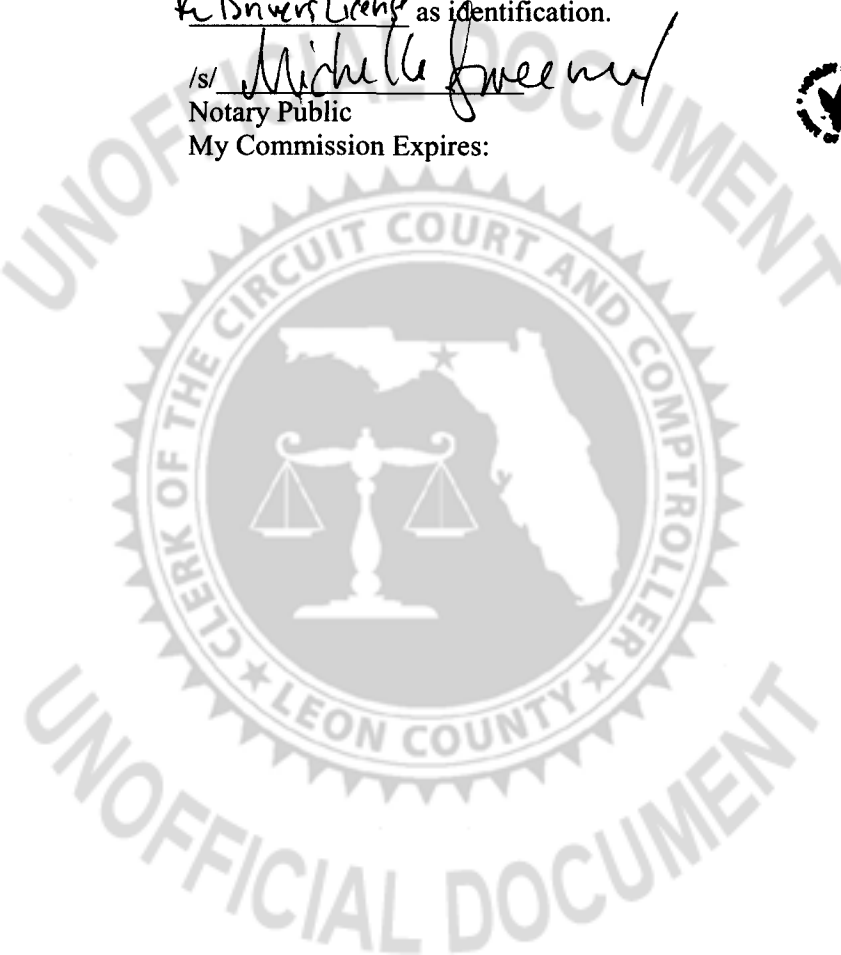

Containing 1.89 acres, more or less.

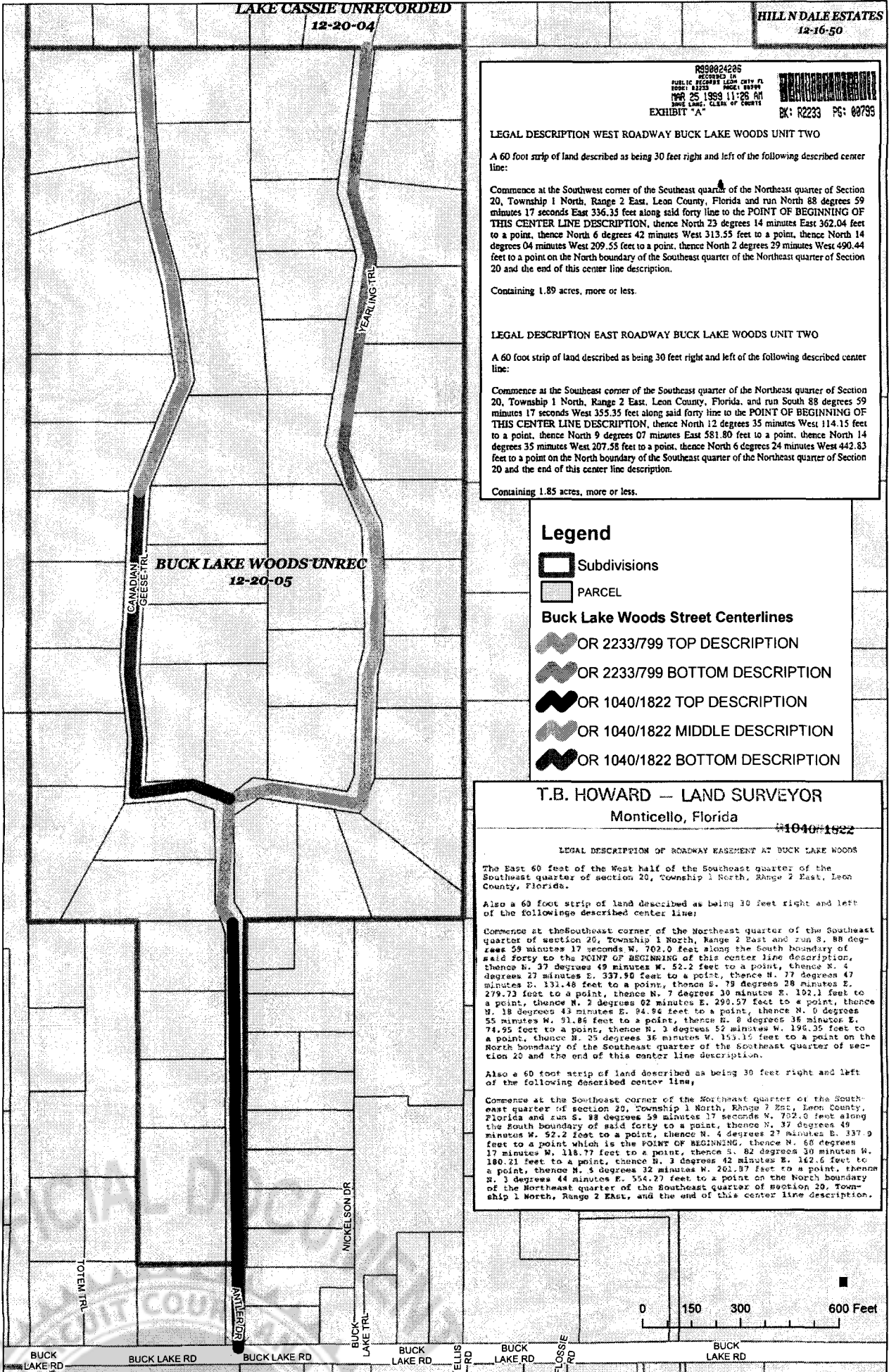
LEGAL DESCRIPTION EAST ROADWAY BUCK LAKE WOODS UNIT TWO

Commence at the Southeast corner of the Southeast quarter of the Northeast quarter of Section 20, Township 1 North, Range 2 East, Leon County, Florida, and run South 88 degrees 59 minutes 17 seconds West 355.35 feet along said forty line to the POINT OF BEGINNING OF THIS CENTER LINE DESCRIPTION, thence North 12 degrees 35 minutes West 114.15 feet to a point, thence North 9 degrees 07 minutes East 581.80 feet to a point, thence North 14 degrees 35 minutes West 207.58 feet to a point, thence North 6 degrees 24 minutes West 442.83 feet to a point on the North boundary of the Southeast quarter of the Northeast quarter of Section 20 and the end of this center line description.
